

Terms and conditions of the “We move, you win” competition

- 1) This terms and conditions (here in after referred to as Terms) stipulate the rules and conditions of the “We move, you win” competition in a hackathon event such as HackYeah and is an annex to the general terms and conditions of HackYeah Hackathon.
- 2) The Hackathon Partner within the meaning of art. 921 § 3 of the Civil Code (Journal of Laws 2019, item 1145) is Bosch Rexroth Sp. z o.o., with registered office in Warszawa 02-231, ul. Jutrzenki 105, registered under following numbers: NIP (Taxpayers ID no): 534-00-01-550 and REGON (Business ID no): 012007062, entered into KRS (National Court Register) under number 0000036334, which may be reached at info@boschrexroht.pl e-mail address.
- 3) Details of the task will be presented at the start of the competition.
- 4) Participation in the “We move, you win” competition may be taken individually and in teams of up to forwarded the task for evaluation no later than 12:00 on September 15th. The task submitted for evaluation should be signed with the names and surnames of the authors.
- 5) Participants related or affined to the second degree with members of the ““We move, you win”” competition Jury, as well as with promising the prize, are excluded from participation.
- 6) The Contest task is to present the idea of a new game. The solutions of the tasks will be evaluated by a Jury assigned to the task, consisting of at least two members. The prize in the competition is 20 000 PLN (including tax).
- 7) Jury and Jury members’ decisions are final and cannot be appealed.
- 8) Any alterations or revisions made after the statutory time is expired are illegal. Any alterations and revisions made after the statutory time is expired will not be considered by the Jury.
- 9) At the time of paying out the prize as stipulated in Point 6 above, Bosch Rexroth Sp. z o.o. acquires the ownership rights to the idea that won the contest, including the copyrights to the idea on all fields of exploitation existing at the date of the transfer of copyrights, in particular on those fields stipulated in Article 50 of the Polish Copyright Act:
 - a) in the field of recording and reproduction of the idea - production of copies of the idea by a specific technique, including printing, reprographic, magnetic recording and digital techniques;
 - b) in the scope of trading the original or copies on which the idea was recorded - placing on the market, lending or renting the original or copies;
 - c) in the scope of disseminating the idea in a way other than specified in point b - public performance, exhibition, displaying, reproducing, broadcasting and rebroadcasting, as well as

making the idea available to the public in such a way that everyone can have access to it in a place and time of their choice.

Bosch Rexroth acquires also the rights to modify the idea or to develop it further.

10) Jury members will be posted on HackYeah website no later than on September 13rd 2019

11) Participation in the competition means acceptance of all terms of the hereby Contest Rules.

12) The Partner may cancel the Contest without giving a reason.
